Also, apart from this we were supposed to apply the indicators as and when we learned in the market to a particular stock using Upstox application. Overall, it includes activities like, monitor trading performance, learning of trading systems and techniques, researching and resolving issues in trading areas, maintaining and reporting of activity and analysing and making another advertising methodology.

#### e. Business Sector




Figure 1 – Mutual Fund's AUM Yearly Source – Times of India




Figure 2 – Investor Break-Up Source – IBEF Services




Figure 4 – NPCI Transactions Source – Times of India

#### **b.** Project description

3. Research & Resolve Issues in Trading Area

The company requires an individual to manage various issues which emerge during ongoing stock market and its performance.

4. Maintain & Document Activity

During this internship they need us to track the stocks that individual has personally selected and justify for selecting the same. Based on the overall performance and based on the journal entries have been made by individual one will be judged.

- 5. Provide Prospects with general information and help them with training
- 6. Analyzing & Creating new marketing making trading strategies

They need us to examine the current marketing technique and suggest the changes, if any.

- 7. Paper Trading for training
- 8. Build Quality Relationships with industry participants

#### c. Project Objectives and Deliverables

The aforementioned project areas helped in learning the specialized and crucial investigation of the stock market, which is further useful in taking the stock for short or long period as well. During the internship, it helped me gain proficiency with the accompanying techniques for examining the stock including Technical analysis as follows –

- Japanese Candlesticks
- Indicators and oscillators
- Chart Patterns
- Fibonacci Retracements
- Pivot Points
- Moving Averages
- Trend Reversals
- Intraday Trading Strategies

Alongside this, also learned about various techniques related to Fundamental analysis for major examination of the stocks as follows –

- Economic Calendar
- Market Sentiments
- News Releases
- Company Analysis
- Political factors affecting the momentum of the market
- Interpreting the worldwide cues and their effect on the performance of the market

These analyses helped in assisting and dealing with the portfolio for the momentary time span. Aside from that, it will permit in taking stocks for intraday trading purposes. Also it would help making an exchange for the long term period and deal with the portfolio for the same period and capital additions.

#### d. Project Tasks

The internship was planned as such where the association showed the ideas that were expected to pick a stock for exchanging and trading reasons. Post the meeting, requirement was to execute the ideas instructed in the session in the stock exchange market. It was possible that one can take the exchange with their own cash or go for paper trading, the decision was own self. The task was to keep a journal of each exchange which was made on a specific day. All through the temporary position with The Growth Arrow Company till date, the following have been taught during the sessions –

1. About the Stock Market –

In this they guided and trained students about the nuts and bolts like what is securities exchange and how one's an investment fund can be channelized to procure more and over the long run increase itself and develop the capital.

2. Different kinds of Technical strategies -

Here the guide showed and made us understood what are diverse specialized investigation techniques and how are they arranged into conventional just as present day strategies. Likewise showed what is backing and opposition and how to discover one taking a gander at the candle graph of any stocks. One share was allocated the errand for the following day to discover backing and opposition of any 5 loads of shares of own decision and take up exchanges of the similar taking and look at the gander with candles help and obstruction.

#### 3. OHLC Strategy and Pivot Point -

The guide showed and taught about OHLC in the candle outline and how the OHLC system functions in the early hours of the financial exchange. Then likewise encouraged indviduals about the rotate point and turn levels and how the turn levels assume a significant part in the diagram designs. One was relegated the undertaking for the following day to examine any 5 stocks and apply the OHLC and Pivot point system and screen them over the market hours.

4. Candlesticks Patterns (1) –

The guide showed us various kinds of candles designs like Big black candle, Big white candle, the morning star, and evening star and how the previously mentioned designs assume a significant part in pattern inversion like from bearish to bullish or the other way around. Then likewise the mentor trained about what time span outline to search for while deciding the patterns in present moment, long haul, and intraday premise. One share had approached to contemplate outline examples of 5 stocks and discover the candle examples and screen them during market hours.

5. Candlestick Patterns (2) –

The guide kept instructing the other various candle designs like doji, hammer, altered sledge, tombstone, dragonfly bullish inundating, and bearish immersing and furthermore showed us how the examples assume a significant part in popular. 6. Intraday Trading Strategy –

7. Bollinger Bands –

One was shown about the significance of the bollinger groups pointer and what it shows on the diagram. Then one was guided about how to take up any exchange, considering a gander at the candle graph and bollinger levels. One was approached to take 5 exchanges from the live market utilizing Bollinger groups and the candles design taught beforehand and screen them with very similar patterns during market hours.

8. RSI and Stochastic Indicators -

One was instructed about relative strength marker and the stochastic oscillator and also about how these markers assume an indispensable part in deciding the pattern of the stock, regardless of whether the stock is overbought or oversold and hence can be resolved with these markers. Additionally, about what levels of RSI and Stochastic to be engaged upon prior to taking up any exchange were also taught. One was approached to take 5 exchanges the open market dependent on our learning and information on the RSI and Stochastic Oscillator and screen them during the market hours.

9. Moving Average -

One was instructed about the moving midpoints; simple moving midpoints and outstanding moving midpoints. Then likewise showed about what time spans to search for in moving midpoints and how moving midpoints fill in as help and opposition for a stock. One was approached to take up exchanges on every one of the things instructed beforehand and moving midpoints and screen the shares with very similar patterns on the lookout.

10. Fibonacci Levels –

The guide showed about the Fibonacci retracement levels and how similar these aides in deciding the help and obstruction levels of the stocks. Then advised about which Fibonacci levels to consider prior to taking up any exchange. Also, one was approached to fuse Fibonacci retracements alongside every one of the recently shown strategies and take up an exchange in the live market.

11. Futures and Options Concept -

The guide presented about the subsidiaries market from the stock market. Also, clarified about what the subordinate market is and how it functions. Then added about the prospects and alternatives exchanging. One was approached to exchange prospects and alternatives in the live market and screen performance with very similar patterns during the market hours.

12. About Foreign Exchange Trade -

After such sessions, an another session on foreign exchange trading was held. In which we were given a task to get a registration for the company's internship program till 15th of June. In the foreign exchange session we were given brief introduction about the market and its advantages and much other information related to it. Then we were instructed to create a demo account for foreign exchange on Fidelis Capital Market. In the next session we were given guide how to trade on foreign exchange market and how and on what basis to decide the trading. In that demo account we are given fake digital currency to trade and get to know the market better by trading in that demo account. Hence we were given another task to trade in that demo account. Then I worked on the second task to find a registration with which I will get the opportunity to receive the certificate of foreign exchange trading session. I reached out to my friends and relatives and asked them whether they will like to study and know more about the stock market and how to trade using various technical and fundamental tools. Finally after a lot of hard work, I convinced one of my friend and she agreed to register for this course and create a demat account and mention my name as referral.

13. Fundamental Analysis –


In this sessions, the guide taught and guided us through the various fundamental analysis indicators. This indicators include economic calendar, market sentiment, news releases, company analysis, political factors and interpreting global data. This all was taught by taking the help of an example of the company reliance. Each indicator was taken and was explained

in detail and was shown how to analyse each thing and then to take a comprehensive decision. Also were explained how the news releases affect the stock market and how the political factors affect the market.

#### • JAPANESE CANDLESTICK


Candlestick charts were created in Japan over a century before bar and point-and-figure charts were invented in the West. While there was a relationship between pricing and rice supply and demand in the 1700s, a Japanese man named Homma observed that the markets were heavily impacted by merchants' emotions. Candlesticks depict this emotion by using different colours to graphically convey the size of price movements. Traders use candlesticks to make trading decisions based on patterns that appear on a regular basis and help anticipate the price's short-term direction.

#### • INDICATORS & OSCILLATORS


Oscillators are chart indicators that can help a trader determine if a market is overbought or oversold in a range (non-trending) environment. To validate range extremes and determine crucial entry and exit points, most traders utilise several oscillators. The RSI is a common oscillator that determines whether an instrument's price is overbought or oversold by measuring the magnitude of recent price movements.

• CHART PATTERNS

There are various chart patterns in the stock market, some of them are reflected with the help of image. The cornerstone of technical analysis is patterns, which are unique forms formed by the movements of securities prices on a chart. A pattern is defined as a line that links frequent price points over a period of time, such as closing prices, highs, and lows. Technical analysts and chartists look for trends in order to predict how a security's price will move in the future. Trendlines and double head-and-shoulders formations are two examples of these patterns.

#### • FIBONACCI RETRACEMENTS

Fibonacci retracement levels link any two points that the trader considers important, usually a high and a low. The percentage levels given represent places where the price may halt or reverse. 23.6 percent, 38.2 percent, 50 percent, 61.8 percent, and 78.6 percent are the most often utilised ratios. It is risky to presume the price would revert after hitting a certain Fibonacci level since these levels should not be relied on entirely.

#### • PIVOT POINTS

A pivot point is a technical indicator used to detect trends and reversals in the stock, commodity, and currency markets on an intraday basis. Pivot points are used to identify when the market's mood is likely to shift from bullish to negative, and vice versa. Pivot points are used by day traders to define entry, stop, and profit-taking levels.

• MOVING AVERAGES

In technical analysis, a moving average (MA) is a stock indicator that is widely employed. The purpose of generating a stock's moving average is to smooth out price data over a set period of time by establishing an average price that is continually updated. A simple moving average (SMA) is a computation that takes the arithmetic mean of a collection of prices over a certain number of days in the past, such as 15, 30, 100, or 200 days. Exponential moving averages (EMA) are a weighted average that lends more weight to a stock's price in recent days, making it a more responsive indicator to fresh information.

#### • TREND REVERSALS

When the direction of a price trend changes from up to down, or vice versa, it is called a reversal. Traders aim to get out of trend-following positions before a reversal occurs, or they will get out once the reverse has begun. Reversals are major price shifts in which the trend reverses direction. Pullbacks or consolidations are little counter-movements against the trend. When it starts, it's difficult to tell the difference between a reversal and a retreat. A reversal continues and creates a new trend, whereas a retreat stops and the price returns to the prevailing direction.
